ROUTES TO BUSINESS SUCCESS

The Cass MSc in Global Finance has the potential to open up global career opportunities for you in a rapidly changing and ever more complex business environment. It equips you with a combination of high-level interpersonal skills, in-depth knowledge and analytical skills.

COURSE STRUCTURE

The course is designed so that you can manage the workload alongside your professional and domestic commitments.

- Complete within 24 months
- 12 modules. You study one module at a time and each module runs for a manageable seven weeks
- Start when most convenient for you, with intakes in January, May and September

ENTRY REQUIREMENTS

- An undergraduate degree in a relevant subject area equivalent to a UK 2.1 or higher
- Strong communication skills including a well-balanced IELTS score of 7.0 with no less than 6.5 in writing for applicants whose first language is not English
- Good levels of financial literacy and numeracy are essential. In addition, knowledge of the finance industry would be beneficial.

There is no GMAT requirement for this course.
